Green Tick® Sustainable -the SUSTAINABLE brand
This brand shows that a product meets the GreenTick® Sustainability Standards.



Green Tick® Carbon Neutral -the CARBON NEUTRAL brand
This brand shows that a product meets the GreenTick® Sustainability Standards, and that it has been certified as carbon neutral.



Green Tick® Carbon Negative -the CARBON NEGATIVE brand
This brand shows that a product meets the GreenTick® Sustainability Standards, and that it has been certified as carbon negative.



Green Tick™ Organic - the ORGANIC brand
This brand shows that a product or service has been certified as genuinely sustainable, and that it holds a current organic certification.



Green Tick™ GE-Free - the GE-FREE brand
This brand shows that a product has been certified as genuinely sustainable, and that it contains no genetically engineered content.



Green Tick™ Natural - the NATURAL brand
This brand shows that a product has been certified as genuinely sustainable, and that it contains only natural product content.



Green Tick™ Fair Trader - the FAIR TRADER brand
This brand shows that a product or service has been certified as genuinely sustainable, and that it is produced according to fair trading principles.

Green Tick® Sustainability Standards

The Green Tick® Sustainability Standards follow international principles for sustainable management, according to ISO protocols.

The standards are life-cycle based “from cradle-to-grave”. This way the consumer gets the whole story about a product or service.

The standards cover:

- site, employee, supplier and customer health and safety;
- product origin, quality, and labelling;
- resource, chemical, and energy use;
- nuisance effects;
- contaminant discharges;
- waste management;
- environmental management systems and performance; and,
- legal compliance.

Types of Certification

There are three types of certification.

- Corporate, Site and Product

Certification Process

The Certification Process involves four steps:

- Preparing for certification;
- Making an application;
- Undergoing an audit by an independent auditor; and,
- Entering into a license agreement to use the Green Tick® Brand.

Costs and Timing

Costs comprise:

- Application Fee of \$US200 minimum per site or product;
- Independent Auditors Fee - this will vary according to the location, size and status of the operation; and,
- Royalty Fee for use of the Green Tick® trademark - negotiable, usually based on a small percentage of net sales of the certified product or service.

Timing - certification normally takes about 3 months to achieve, with longer timeframes for some products and services.
