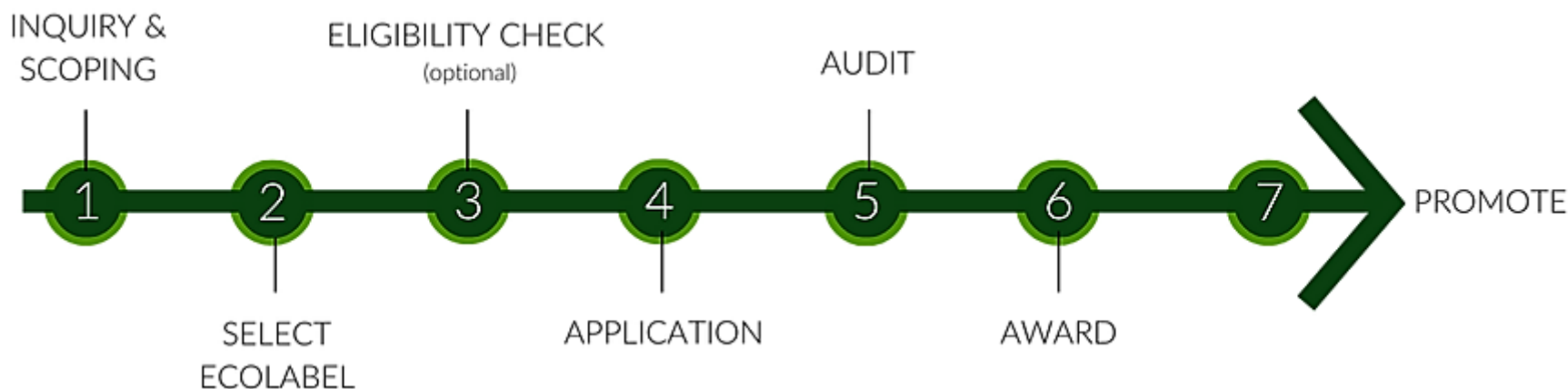

# Minimum Requirements

- **Definition of sustainability:**

*“Operations under the Applicant’s direct control do not cause permanent harm to people or the environment.”*

- **Apply for at least one product (or service) and one site**

- **Define Scope of certification** – operational or financial control, eg.  
*Operational Control: Inwards Goods to Outwards Goods*

- **Provide at least 12 months’ evidence of compliance** with Health, Safety, Environmental Standards of ecolabel sought. Detailed Audit Checklist available.

- **Acceptable evidence types:**

- Life cycle assessment (LCA)
- Environmental, Social, Governance (ESG) records
- Sustainability Statement and performance records
- Existing third-party reports, eg. ISO 9001, ISO 14001, ISO 45001, SMETA
